Artists juried into the show will be notified by January 25<sup>th</sup> and matted pieces will be **hand delivered to the Alliance for the Arts on January 30<sup>th</sup>** between **9-5 PM**. Entries must include artist's name, address, phone number, email address, title, medium and price. Please indicate orientation on the **top right corner** of the image with an upright arrow.

### SPECIFICATIONS FOR PHOTOGRAPHS JURIED INTO THE EXHIBIT:

All photographs **must be 8 x 10 inches**.

All work juried into the show **must be matted but NOT FRAMED**. Black matte only.

**AWARDS:** \$100.00 Best in Show; 2<sup>nd</sup> Place \$75.00; 3<sup>rd</sup> Place \$50.00; Jurors & People's Choice Awards

**EXHIBIT SUMMARY:** Photographs juried into the show will be on display at High Point Place in downtown Fort Myers from Tuesday, February 7 through February 12 as part of the 2012 Symphony Designer Showcase. Award winning pieces (1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, Jurors & People Choice) will travel to a variety of venues for 30 days following the 2012 Symphony Designer Showcase. Unsold pieces will be available for pick up at the Alliance for the Arts on Wednesday, February 15, 2012. Artists will be notified by email/phone if they need to pick up their work.

**LIABILITY:** Every effort will be made to handle photographs with care, including protection from loss. The Southwest Florida Symphony, High Point or the Alliance for the Arts will not be liable for any loss or damage caused or occurring while work is in exhibition or while displayed on the My River District website. By submitting to the 2012 Fort Myers City Lights – A Photography Show artist gives irrevocable, non-exclusive, worldwide, perpetual, transferable right to The City of Fort Myers to use the submission image, and to publicly display the submission image, in whole or in part, in any format or media now known or hereafter developed for any and all publicity purposes. ***The artist's name & piece title will be included in any and all future publicity.*** Submitting images through the Entry Form is an acknowledged agreement to these conditions.

**SALES:** All submitted works selected for inclusion and display during this exhibition may be offered for sale to the public at a labeled price set personally by the artist. Entries may be listed as "Not for Sale" (NFS), but must state an insurance value. A 50% commission will be retained by the Southwest Florida Symphony on all work sold during the exhibition.
