## **Update on Evolution of the Symphony Support Organization**

For several months, members of the Southwest Florida Symphony Society, Southwest Florida Symphony Board of Trustees and staff have gathered in meetings to ponder ways to strengthen, modernize, simplify and revitalize the volunteer organization that supports the Southwest Florida Symphony. The thoughtful involvement of so many people has been inspiring and is greatly appreciated.

Members of the Symphony Society who attended the April luncheon were introduced to the following basics regarding the modernized support organization.

### Dues, Benefits & Name

The Symphony support group will continue to be membership based, with dues and benefits for being a member. Dues will remain at the current level, i.e. \$50 for Active members who will participate in the work of the organization and \$75 for Patron Members who wish to support the organization without a commitment to serve.

In addition to benefits currently offered to Symphony Society members, additional benefits, in the form of discounts and experiences, are being developed.

We welcome suggestions on a name of the support group. We are looking for a friendly name. The simpler the better. Please send any suggestions to Liz Marnul (lizinswf@live.com) or Anne Wardlow (awardlow@yahoo.com).

### **Team Structure & Transactions**

The support organization will have a Team structure. Active members will participate in Teams according to their interests.

Teams will include: Fundraising, Education & Scholarship, Community, Hospitality, and others.

Each Team will include at least one member of the Board of Trustees who will serve as the Team's liaison to the Board and as a resource to facilitate the Team's work. Staff will also support Team efforts as necessary.

Each Team will designate a "lead" to coordinate Team efforts and represent the Team at regular meetings of all Team Leads.

With this new structure, there will be no need for a Board, officers, minutes, etc.

Transactions will be automated and done online.

Monetary transactions and accounting will be handled at the Symphony level.

Processes will be more modern and simple, once all the new procedures are in place. It will take a lot of initial work to simplify and modernize transactions, but it will be worth it!

#### Newsletter

A monthly digital newsletter, called "The Score", will be distributed to the Symphony's email list.

A new volunteer, who has designed and published digital newsletters professionally, has generously offered to publish the new digital newsletter for the Symphony. It will include Symphony information, feature articles, articles about musicians, and reports on activities of the Teams.

#### **Luncheons & Social Events**

The Hospitality Team will organize and plan all social gatherings, including luncheons, Happy Hours, brunches, etc. which offer members an opportunity to gather for social enjoyment.

Luncheons will be offered, but not every month. Instead, luncheons will be presented periodically which will be compelling events of interest to a wide audience, rather than a business meeting.

### What to Do Now?

While there are still lots of details to be worked out, members attending the April luncheon expressed enthusiasm for the new plan.

Society members are encouraged to submit dues for next season, along with a contribution to the Scholarship fund. A Scholarship Team is already forming.

Stay tuned for more exciting updates! In the next few months, we will be asking for members to select and participate in Teams of their choice.

this year's Young People's Concert, entertaining and educating close to 1800 kids, we welcomed Robert Van Winkle to our administrative staff....and we all continue to be smitten with him!...and next year, the Society will blossom into something beautiful and exciting. Please keep an eye on your inboxes and our website for developing information on upcoming events and opportunities throughout the summer! Yes, you read that correctly; we will hold occasional summer events to keep our community engaged and nurture the relationships we've fostered through live music.

Finally, we can announce concert dates and programming highlights for our 63<sup>rd</sup> season and you are (outside of our musicians) the very first to see these highlights! Here's what's on tap for next season:

Saturday, October 21, 2023 – Brave New Pops R.E.M. Explored – the music of 1980s/90s alternative rock band R.E.M. reimagined for orchestra AND a Concerto for Violin, Rock Band & Orchestra

**Saturday, November 4, 2023** – MasterPops! This is both a Masterworks and Brave New Pops: The Marcus Roberts Jazz Trio performs a jazz arrangement of Gershwin's Rhapsody in Blue

**December 9 – 11** Holiday Pops at three locations throughout Lee and Charlotte Counties Andrew Lipke returns with his Holiday Pops program written and arranged specifically for the Southwest Florida Symphony. If you missed the 12 Days of Florida Christmas last year, now's your chance to catch it!...and it is spot on.

Saturday, January 6, 2024 – <u>Charles Yang</u>, violinist from Time for Three is our celebrity guest artist who will, once again, fuse traditional and contemporary orchestral music. Charles will perform the Ravel Tzigane, then will offer a few musical surprises.

Saturday, February 3, 2024 – Locally beloved pianist <u>Alexandra Carlson</u> returns to perform Prokofiev's 3<sup>rd</sup> Piano Concerto.

Saturday, March 16, 2024 – Our very own "rock star," <u>Orin Laursen</u> is our soloist on this program, performing the Beethoven Violin Concerto.

Thursday, April 4, 2024 – We close the <u>Tribby Arts Center</u> Concert Season with Maestro Radu Paponiu making his long-awaited debut for an exclusive Tribby engagement, featuring Jillian Prescott Scholarship Competition winner who began his career right here in Southwest Florida, pianist, Arturo Fernandez, performing Bach's Piano Concerto in D minor.

Saturday, April 13, 2024 – Prodigy cellist, Sterling Elliott closes out our Masterworks Season with the Tchaikovsky Rococo Variations

Saturday, May 18, 2024 – Andrew Lipke returns to conduct our Final Brave New Pops of the season, the Orchestra meets MTV Unplugged. This program, also curated and arranged by Maestro Lipke, connects the dots between orchestral music and its influence on acoustic rock & roll. It will also feature a multimedia component taking Gen Xers and their parents who consumed MTV in its heyday on the coolest trip down memory lane.
